OPENING RECEPTION: October 9, 2:00 to 4:00 PM, Searcy Art Gallery, 300 Race Street, Searcy, Ar.

ELGIBILITY: open to all MSW members in good standing. Prepaid entry fee \$5.00.

Submit 1 or 2 painting(s) between 5:30 and 7:00 pm, September 15. Judging by Gary Simmons will start promptly at 7:00 pm. The exhibition will consist of 40 paintings.

PAINTINGS must be water media on watercolor paper and original to the artist in concept and execution. No copies. No paintings previously shown in an MSW show may be entered.

FRAMING AND SIZE LIMITATIONS: No piece larger than a full sheet (22 X 30) may be entered. Simple frames required, no ornate frames will be accepted, wire hanger only. - Use Plexiglas (no glass). Mats must be neutral: white, off-white, light gray or beige, no pastel or dark mats.

SALES: Paintings sold must remain on display until end of exhibition.

The Searcy Art Gallery will retain 30% of the selling price.

DELIVERY DATE: "Other Exhibitions Committee" will deliver the Artwork to the exhibit.

If you DO NOT want your painting to travel to the Searcy Art Gallery check no on your entry form. The painting(s) delivered BY THE ARTIST to Searcy will be October 1, 2:00-5:00 pm.

PICK-UP DATE: MSW Meeting November 17, 2010 or by the artist November 16, 2010.

LIABILITY: Although utmost care will be taken in handling paintings, neither MSW nor its representatives or Searcy Art Gallery will be responsible for damage or loss, whatever the cause. All work will remain as placed in the Searcy Art Gallery and no work can be removed before the close of the exhibition. Sending artwork to this exhibition shall imply an agreement on the part of the Artist with the conditions set forth above.
